

FREQUENTLY ASKED QUESTIONS REGARDING GUARDIAN ACCESS CARDS

1. What do I need to do in order to get a guardian amenity access card so that a guardian may take my child/children to the pool? Bring the completed, notarized guardian access card form to the Resident Services office during office hours. The parent requesting the guardian access, the guardian, and the child/children must be present in order for the card to be issued.
2. What are the office hours? Monday-Friday 9:00 – 5:00, by appointment only.
3. What identification must the guardian bring? A photo identification and proof of age that the guardian is 18 years of age or older.
4. Is there a minimum age limit for guardianship? Yes, guardians must be 18 years of age or older.
5. What identification must the parent bring? The requesting parent must have established proof of Fishhawk Ranch CDD residency in the form of a valid Fishhawk Ranch CDD amenity access card.
6. For what period of time is the guardian card valid? One year from the date of issue. For residents who are leasing, the guardian card will expire one calendar year from date of issue or at the end of the current approved lease period, whichever occurs first.
7. Can I get more than one guardian card? You may have up to two guardian cards in effect at any given time. If your established guardian changes, you may repeat the application process, at which time the previously issued guardian card will be deactivated. The \$21 processing fee will apply each time a guardian card request is processed.
8. Can the guardian bring guests to the pool? No, the purpose of the guardian card is specifically to allow a guardian to bring minor resident children under their guardianship to the pools or other applicable amenities.
9. Can the guardian come to the pool alone? No.
10. May the guardian use the fitness center? No, because minor children are not permitted in the fitness center, there would be no need for the guardian to have access to the fitness center.
11. What is the fee for a guardian card?
 - a. \$21.00 for each guardian card/request that is processed.
 - b. \$5.25 for each child's photo identification card that is processed.
 - c. Lanyards available for purchase for \$3.15 each.
 - d. Payable by credit or debit
 - e. Should a facility access card be lost or stolen there is a \$21.00 charge to replace it.

LIMITED GUARDIANSHIP POWER OF ATTORNEY

Up to (2) Guardian Family Access Cards may be issued to a Resident Family, Non-Resident Member Family or Renter Family at any one time. There is a \$21.00 charge for this card. The person being issued this card must be at least eighteen (18) years of age. An executed and notarized Guardianship Power of Attorney Form including Medical Power of Attorney for each child under the age of fourteen (14) they will be responsible for is required. This card is good for one (1) year from the date of issuance. The Guardian is not allowed to use the Amenity Facilities unless using them with the child or children assigned to the card. The Guardian is also not allowed to bring guests to the Amenity Facilities at any time. The child or children assigned to the Guardian Card will be required to obtain a Child Identification Card. There is a \$5.25 charge for this card.

As their guardian I hereby grant to the guardian the power and authority to perform all acts necessary to exert management and control over the behavior and well-being of any or all of my children listed below and make any medical decisions that become necessary in the absence of my ability to timely communicate my decisions in such matters at any time when any or all of my children listed below are accessing Amenity Facilities within the Fishhawk Ranch Community Development Districts in the company of the designated guardian.
4. I acknowledge that this designation is for the purpose of allowing my minor children to access Amenity Facilities when accompanied by the designated guardian without my presence being required and that nothing herein modifies or terminates my parental rights and responsibilities. The power herein granted to the guardian is only effective when my children utilize the Amenity Facilities under the supervision of the designated guardian.
