FIRST ORDER OF BUSINESS

Call to Order and Roll Call

Mr. Dailey called the meeting to order and conducted roll call, confirming that a quorum was present.

SECOND ORDER OF BUSINESS

Public Comment

No audience comments.

THIRD ORDER OF BUSINESS

Suspension of Amenity Privileges

A. Review of Suspension and Incident Reports

Mr. Craine reviewed the incident reports and the suspension process with the Board. The Board discussed the reports and Mr. Bragg addressed the Board regarding the current suspension. Following repeated requests and warnings by the Board and District Staff, Mr. Bragg would not comply with the process when addressing the Board, he was asked to leave the meeting by Officer Cruz with the Florida Highway Patrol.

On a Motion by Ms. McDougald, seconded by Mr. Avino, with all in favor, the Board approved to suspend all amenity privileges for Mr. Francis Bragg for one (1) year, for Fishhawk Ranch Community Development District.

FOURTH ORDER OF BUSINESS

Staff Reports

A. Community Manager

Ms. Quigley presented the operations report to the Board.

Ms. Quigley updated the Board on the process with the Hawk Park clubhouse cleaning and renovation options.

On a Motion by Ms. McDougald, seconded by Mr. Avino, with all in favor, the Board authorized the Hawk Park Clubhouse renovation for wall removal, bathroom remodel and the addition of rubber flooring in the back and requested that all work be in compliance with applicable ADA with a not-to-exceed amount of \$30,000.00, for Fishhawk Ranch Community Development District.

Ms. Quigley updated the Board on a new leak in the Palmetto Club roof.

On a Motion by Ms. Brown, seconded by Ms. McDougald with all in favor, the Board authorized the Chairman to execute a proposal for the Palmetto Club roof repair at a not-to-exceed amount of \$15,000.00, for Fishhawk Ranch Community Development District.

Ms. Quigley stated the repairs are completed and Starling Club water park will reopen Wednesday, October 23, 2019.

Ms. Quigley stated a charity event has been set for the Palmetto Club for January 25, 2020 for the Fishhawk Youth Baseball. Puff N' Stuff waived their fees for the event.

B. Landscape Inspection Report

Mr. Toborg reviewed his report with the Board and stated all the outstanding CLM proposals have been completed.

Mr. Toborg has requested a proposal from CLM for the Phoebe park landscape lighting.

Mr. Toborg asked who is responsible for the Tract 12 landscaping and maintenance, Mr. Craine stated he will review and update the Board.

C. Irrigation Inspection Report

The Board reviewed the irrigation report.

D. Pond Inspection Report

The Board reviewed the pond report.

Mr. McGarry will provide treatment for the lily pad growth on ponds 11, 20 and 21.

Mr. McGarry and Mr. Brletic both stated the DRA's in Starling are still too wet to be able to mow 100%. The vendors will continue to mow as much as they can as they dry out.

I. Presentation of Pricing for Nano Treatment and Aeration Options

Mr. McGarry reviewed with the Board the various treatment options and pricing. Mr. McGarry stated the nano treatment for ponds 4 and 15 will cost \$26,900.00 to install the system plus electricity in addition to \$11,460.00 in annual maintenance. Mr. McGarry then stated the aeration systems for ponds 4 and 15 will cost \$9,316.00 to install plus electricity and annual maintenance. Mr. Brletic estimated the cost in the area of \$10,000.00 per unit for electricity to be installed.

E. Tennis Report

Mr. Sanderson presented his report to the Board and discussed financial penalties for Mr. Freiman if no update is provided. The Board requested that Mr. Freiman attend the November 19, 2019 meeting if the financial reporting capabilities of the new software system have not been activated by that date.

Mr. Dailey presented two proposals to the Board for the tennis club courts and sidewalk drainage repairs. The first proposal was from Finn Outdoor for \$9,850.00 and the second proposal was from G.A. Nichols for \$11,400.00. Mr. Dailey asked about Finn Outdoor's experience on projects like this. Mr. Brletic stated he has worked with them in the past and is confident in their ability to complete the project as designed.

On a Motion by Ms. McDougald, seconded by Ms. Morrison, with all in favor, the Board approved the Finn Outdoor proposal in the amount of \$9,850.00 for Tennis Club drainage repair, for Fishhawk Ranch Community Development District.

F. District Engineer

Mr. Brletic distributed a GCE aquatics engineer report to the Board. Mr. Brletic reviewed his report with the Board. The Board asked Mr. Brletic to get a proposal for various options to repair or replace the Aquatic Club vault.

I. Consideration of TECO Trail Plan Design Proposal

The Board reviewed the TECO Trail Plan Design proposal for \$18,140.00, and asked staff to investigate less expensive repair alternatives and bring them back for review.
